Your Board of Directors wishes you the best for a safe and enjoyable holiday season!

We have just finished several major projects, including painting in Courts 7, 8, 9, and 10, and a roof replacement at 3427-3431 S. Stafford in Court 4.

We are also wrapping up the sewer lateral relining work for 2007, which gets us about half-way through this major capital improvement project. Jack, José, and Ron Kirby, our onsite engineer, have been working very hard monitoring the sewer relining contract. Some of the relining can be done through the manholes, but other work requires the digging of 12-15-foot deep pits in order to reach the pipes. Placement of some of the pits has been tricky, as they are located close to the buildings or fences. One, in particular, had to be dug in the small space between a resident's outside garden and Dominion Electric's lines.

To ensure workers' safety, the water must be turned off. Residents were given notice of when the water would be off, but to our surprise some of the water lines feed buildings in unexpected places. For instance, when the water was turned off for work in Courts 4 and 5, it went off

unexpectedly in three buildings in Court 3. The same thing happened when work was done in Court 15 and it affected at least one building in Court 7. The work has been going very smoothly so far, with the exception of a collapsed lateral that was discovered at 3429 S. Stafford and will require some major digging and repair. Restoration of the affected areas will follow after the soil in the pits has had time to compact, which is essential prior to final grading and seeding.

Following the last heavy rain, settlement of as much as 18 inches occurred in some pits. So, as much as residents don't like looking at these disturbed areas, we must do the work at the appropriate time, or it will just have to be re-done, which is a waste of both money and effort.

We request residents' cooperation and patience with all major work that takes place in the community. This work needs to be done and we are doing it as quickly and as safely as we can, with as little disruption as possible. If you have any questions about any of the ongoing work, feel free to contact John Kilkenny at CMC. If you find yourself feeling frustrated or inconvenienced, please don't take it out on Jack and José.

Our annual meeting in October was well attended, and we thank the 60 or so people who turned out. Once again, between attendees and proxies, we managed to reach a quorum, without which we would not have been able to conduct the meeting or pass the budget. Thanks also to those of you who sent in your proxies and especially to the Court Chairs for canvassing their courts for proxies in advance of the meeting. With their assistance, we achieved a 52 percent response, the highest percentage in recent memory. We had good discussions on the state of the Association-which is excellentas well as the budget and our ongoing capital improvement plans.

Attendees received reports from the Committee Chairs and, in the case of the Buildings & Grounds Committee, from several members, who discussed individual topics.

The 2008 budget was passed through unanimous consent. The condo fee increase for the coming year will be 3.40 percent—a modest and reasonable increase considering the major recurring and special expense items we anticipate for 2008. The new

Buildings & Grounds Update

Fall is in full force and the Buildings and Ground Committee would like to remind all residents that winter is just around the corner. There are energy savings techniques all residents can employ as the cold weather closes in.

Winter, just like summer, is a high energy use season. We can all do our part to make our units warmer and more efficient. It's getting colder, especially at night, so we are all running our heaters more. Heat rises and so much of the heat we use to warm our homes during the winter escapes through the attic. Making sure your attic is properly insulated will help ensure that less heat—and heating dollars—escapes into thin air.

As many residents know all too well, the original windows in Fairlington are very inefficient. Although replacing your windows is quite an expensive home improvement project, you immediately begin to reap the benefits from savings on your monthly energy bill when you replace old windows with newer, more energy efficient ones.

We can also conserve energy by turning the heat

down during the day when you are at work, as well as during the night while you are sleeping. Installing a programmable thermostat can make this much easier to manage.

The colder weather also means that it's crucial we all turn off our outdoor water, so that if pipes freeze and then unfreeze units don't incur severe water damage.

Lastly, it's time to replace the screens in your storm doors and windows with the glass inserts. This will help keep warm air from escaping from your home.

Despite the rain we had during the third week in October, the drought is expected to continue through the winter months. Because of this, the committee postponed the fall planting until early spring to better ensure the new greenery will have a chance to thrive. Please remember that grass goes dormant and doesn't need watering, but trees and shrubs still need a good drink every day or so.

Watering guidelines for 2007 are now listed on the Meadows Web site.

The Garths, neighbors who have been very active in the Meadows, are leaving our community soon. They are moving and will be missed tremendously.

Judi Garth co-chaired the **Buildings and Grounds** Committee with Chuck Edwards, was at one time a member of the Board of Directors, has co-chaired the Pool Committee, and was a Court Chairperson. Her contributions to the community will always be remembered and the Meadows would not have been the same over the years without her involvement. The Buildings and **Grounds Committee wants** to express many thanks to the Garth family for all they have contributed to the Meadows community over the years and wish them all the best in their new home.

condo payment booklets are being prepared and will be mailed out in early December.

The Board has received reports of biting incidents by loose dogs in the community, so please remember that you must keep your dog leashed. Even though you think you have your pet under voice control, please be considerate of others. Letting your dog off the leash is a violation of County laws and Association rules. There are off-leash areas available throughout the County, with one right in Fairlington at Utah Field. Also, our trash hauler would appreciate it if people did not allow their dogs to urinate on the trash bags awaiting pick up—an inconsiderate practice that is extremely unpleasant for the workers. Finally, please be sure to clean up after your pet and dispose of the waste in the proper manner.

As we prepare for the coming winter season, here are a couple of reminders

for all residents: First, sand is the only thing that should be put on icy sidewalks. Certain types of salt and "ice-melt" chemicals will damage the concrete. Second, water to the outside hose bibs should be turned off at the inside valve and the outside water faucet should be left open to prevent water trapped in the pipes from freezing and splitting the pipes. And finally, please don't use screwin hooks or nails to attach holiday lights to the buildings. These damage the wood and mess up the paint. Outside lights must be removed within a reasonable period of time after the holidays. Residents are reminded that they may not climb up on the porch or building roofs to attach lights or ornamentation, or for any other reason. This is a safety issue and also to protect our hard-working but fragile roofs.
