Grounds Contractor: With the new year comes a new grounds contractor. As announced at the annual meeting last October, the Board of Directors, following the recommendation of the Buildings and Grounds Committee, signed a contract with Somerset Landscaping Company.

The Committee, working with our property manager, Jason Eglin, put the contract out for bids in August 2010. Five companies submitted bids and, after much consideration and reference checking, Somerset Landscaping Company of Alexandria was chosen. Somerset is also the grounds contractor in Fairlington Commons and Fairlington Green. The new grounds contract began January 1, 2011. In early spring, the new crew will begin a general cleanup of the beds and lawns.

Quaker Lane: In September, 2010, Ed Hilz, FCA liaison to the County, arranged a meeting with Arlington County representative, Patrick Wegeng to discuss plantings along Quaker Lane. As a result of the meeting, the County has agreed to replace the diseased photinias with hollies. The hollies will help to add additional screening along the street. This work is scheduled for early spring.

**Spring Events:** Committee member Dave Carro is working with the FCA on plans to improve the appearance of the circle in front of the Fairlington

Community Center. Dave will present his plans to the FCA and the B & G Committee in the spring. We'd like to thank him for working on this project.

With the completion of the Fairlington Community Center and its new landscaping, the committee is planning to hold a Meadows yard sale. Look for additional information concerning this event in early spring.

Spring Planting: Even in the cold of winter, the committee is already making plans for a small spring planting. The majority of the planting for trees and large shrubbery will be in the fall. Residents are reminded that the Buildings and Grounds Committee has two plantings each year, one small planting in the spring and a larger one in the fall.

#### **Common Area Plantings:**

Residents who are interested in planting a small flower garden outside a patio, whether in the rear or side of the patio, must first receive permission from the B & G Committee. Please send a request to one of the two co-chairs, and the committee will review it.

Such gardens are subject to removal if the resident does not maintain the space.

Please remember that permission is needed for any planting in common areas, and that these additional plantings become the property of the condominium association.

There are many things to consider when planting. Some of these include the existence of sewer lines and underground utility lines, as well as the type of material planted and its impact on the community.

Trees: The committee would like to remind residents that our trees are living things that need to be nurtured and protected. They should never be used for signposts because nailing or stapling into a tree opens it up for disease. The community spends many hours and dollars protecting our trees, and we can all agree that they are essential to the overall ambiance of the Meadows and all of Fairlington.

Community Pride: The Meadows covers about 22 acres, and all of us need to help with keeping our homes as attractive as possible. Therefore, if you see a bit of debris on the grounds, please consider picking it up and disposing of it. All of us working together will help keep the community looking great!

of long-term goals. The highest-priority items in the categories of Pool, Contracts, Annual Meeting, Budget, Buildings, Communications, Financial, and Governing Documents are now under discussion, and initial plans have been made for accomplishing our goals.

In addition to the Messenger and the Web site (see note on page 1 about our new Web address), the Association employs two other means of communication with residents: Homeowner Link Elite and Meadows Alerts. Complete information on both services, including registration, can be found on our home page. We hope you find these services helpful in staying connected with your Association. Check the Web site often for updates and for answers to any questions you may have regarding the governing documents and other rules.

Speaking of the rules (you knew this was coming!), the following are some of the "hot button" issues, so here again are a few reminders:

Pets must be leashed at all times when in common areas, and residents MUST clean up after their pets. One place in particular that residents seem to mistake for an off-leash dog run and "no-pick-up- area" is the grassy area behind Courts 5 and 6. There are three off-leash dog runs close by (Utah Field, Four Mile Run, and Walter Reed Drive), but picking "it" up is never optional!





To avoid damage to the court signs and the toppling of light poles, please do not lean items against them, particularly items left out for Bia Pickup, and do

not allow your contractors to do so. Big Pickup is for household items only - no construction debris of any kind!

Place trash out only at designated times never at night and never on Sunday.



Do not allow your guests or contractors to park in your neighbors' parking spaces, even during the day, unless you have made such an arrangement, and never park in the court entrances or "piggyback" behind another vehicle.

Interior renovations exceeding \$1.000.00 in cost must be pre-approved by the Board. This is a fast and simple process that imposes no

hardship on residents. Note



that windows and storm doors are not stock items and must be custom made.

Exterior alterations to accommodate ill-fitting windows and doors are not allowed.



Although we like to think of Fairlington as a safe haven, we are not immune

to crime. Last year in the Meadows alone several crimes and other incidents were reported to the Board, including vehicle thefts, stolen vehicles being abandoned on our property, vehicle tampering, and a questionable door-to-door solicitor. Please do not hesitate to contact the police immediately if you witness or even think you are witnessing a crime. The police are very responsive to such calls and would rather investigate a non-crime than know that something went unreported. Alert residents are a huge deterrent to neighborhood crime.

Please be sure to review the recent changes made to our car towing contract with A-1 Towing in the sidebar at the right, so you are familiar with our new policies, which were put into effect to clarify the responsibilities of both A-1 and the Association, and to prevent any potential abuse of towing services. Note that all other terms and conditions of the original contract remain the same.

Once again, best wishes to all our residents for a happy and healthy New Year.

# **New Towing Policy**

The towing contract with A-1 has been revised as follows:

No vehicle shall be towed from Fairlington Meadows parking courts unless a member of the Board of **Directors, Management** Company, or on-site maintenance staff has called with a specific request for towing services. (A list of persons authorized to request towing services was provided to A-1.)

The only exception is that residents may call for towing services if, and only if, an unauthorized vehicle is parked in their reserved space or if their own vehicle in their reserved space is blocked by another vehicle.

The procedures for such towing requests are as follows:

- (a) the resident must make a good faith effort to locate the violator and request s/he remove the vehicle prior to calling the towing company;
- (b) the resident must be present when the tow truck operator arrives;
- (c) the resident must provide his or her name, address, and telephone number to the towing company at the time of towing; and
- (d) A-1 will not reveal the information provided under provision 4(c) to the owner of the towed vehicle. This information will be given only to the authorized persons referenced above.

# Long-time Resident Remembered

Louise Gabel and her husband, Richard, were among Fairlington's "original owners," and raised their four children here. The Gabels moved into Fairlington in 1946, then into their Meadows home on South Utah Street in 1973.

Mr. Gabel passed away in 2004 after 63 years of marriage, and Mrs. Gabel continued to reside in the Meadows. She taught elementary school in Arlington County for 61 years, the last 19 as a full-time volunteer. In spring of

2010 Mrs. Gabel moved to Goodwin House; she made the mile-and-a-half walk to Carlin Springs Elementary each day, where she specialized in tutoring first-graders who struggled to read, and fifth-graders with their math skills. In 2009 Arlington recognized her dedication to children and community with the Ellen M. Bozman Lifetime Achievement Award.

On October 18, 2010, Mrs. Gabel was crossing the street

on her way to school when she was struck by an Arlington school bus carrying students to Claremont, the school where she had begun her career in 1959. She died later that afternoon.

Working with children helped Mrs. Gabel "stay young and useful and happy." Those in the Meadows who knew Mrs. Gabel share in the loss being felt by her family and the community.

# **Recycle More This Year!**

We're very lucky to have curbside recycling here in the Meadows and we are now able to recycle many more items than we were when the program began. Here's an update to help you decide whether to put an item in the trash or out for recycling on Tuesday night.

Meadows guidelines for recycling are the same as Arlington County. The Board is currently in the process of updating our Web site with this information, so a good place to check if you're in doubt is www.arlingtonva.us/departments/

EnvironmentalServices/swd/ EnvironmentalServicesSwd-Curb.aspx. Acceptable items are listed as well as pictured.

Certain items are definitely NOT for recycling and must go in the trash. These include:

- · clam shell containers
- Styrofoam
- plastic cups and food trays, paper plates and napkins glassware
- ceramics
- light bulbs

Some of the most common things that CAN BE recycled and must be placed in the bins are:

- plastic bottles, jugs, and lids marked 1 - 7
- wide mouth plastic containers such as yogurt and sour cream cups
- aluminum cans
- metal food cans
- glass bottles and jars

As far as paper products go, these must be either in a paper (not plastic) bag or securely tied with string and placed next to the bins, NOT in the bins. If they are placed in the bins, it leaves less space for cans and bottles and confuses the process because the newspapers are generally picked up after the bins.

Paper products acceptable for recycling include:

- newsprint
- magazines (glossy or otherwise)

- cereal and food boxes
- cardboard boxes (which need to be broken down and flattened)
- junk mail

Since it always seems like Tuesdays and Wednesdays are more windy than other days, it is important that you bag or tightly secure your paper recycling to help avoid the drifts of newspaper and junk mail that all too often litter our courtyards and streets. PLEASE and do your neighbors and our hardworking trash collectors a favor and bag or tie these items.

For items that don't make the cut for curb-side pick up, see the sidebar at right for nearby recycling options that make it easier to clear your clutter AND make 2011 a green year.

# Safety Tips for Cleaning Up Broken CFLs

Fluorescent light bulbs, including the compact fluorescent light bulbs (CFLs) so many of us are using these days, contain a small amount of mercury sealed within the glass tubing. When a fluorescent bulb breaks in your home, some of this mercury is released as mercury vapor. The broken bulb can continue to release mercury vapor until it is cleaned up and removed from the residence. To minimize exposure to mercury vapor, the EPA recommends following the cleanup and disposal steps described below.

Before cleanup, have people and pets leave the room and air it out for 5-10 minutes by opening a window or door to the outdoor environment. Shut off the HVAC system and collect the materials you need to clean up the bulb and seal it for proper disposal. During cleanup, be thorough in collecting all broken glass and visible powder. Place debris and your cleanup materials in a sealable container. Promptly place all bulb debris and cleanup materials outdoors in a trash container or protected area until materials can be disposed of properly. Avoid leaving any bulb fragments or cleanup materials indoors. For several hours, continue to air out the room where the bulb was broken and leave the HVAC

system shut off. For more detailed information, visit www.epa.gov/cfl/cflcleanup.html.
